MITIGATING MEASURES

The creation of protective forest plantations is the most effective tool in the fight against salt-dust transfer and the mitigation of the ecological condition of the region.
During the period 2018-2019 protective forest plantations were created on an area of 461 thousand hectares and in 2020, 700 thousand hectares are planned.

Declaring "Aral Sea Region – zone of ecological innovation and technology" is designed to give a new impetus to attracting investments and strengthening regional cooperation in implementing new, innovative and modern technological solutions aimed at improving living conditions of the population of the region, the state of the environment of the Aral Sea zone.



February 2019



March 29, 2019

- The First Call for Proposals was announced

June 3, 2019

- Two projects (UNDP/UNESCO and UNICEF/UNFPA joint proposals) with the total budget of \$3.1 mln. were approved by the Steering Committee.

Projects financed

Improving the quality of the perinatal care services to most vulnerable mothers and newborns


Applicants: UNICEF and UNFPA

Total budget: \$ 1,6 mln.

The main activities:

- Improving the infrastructure and equipping 3 perinatal care facilities with modern equipment (Beruniy, Kungrad districts and Nukus city)
- Strengthening the skills of 450 health care providers in perinatal care facilities.

Improving living standards of rural population in Takhtakupir district



Applicants: UNDP and UNESCO

Total budget: \$ 1,5 mln.

The main activities:

- Income generation (establishment of 6 small and medium enterprises for the production of marketable products)
- Ensuring population's access to drinking water (reconstruction and installation of water treatment facility at station Tazakonis and installation of drinking water networks in Beltau and Mulik settlements)
- Improving the institutional infrastructure of the Forestry Department's branches.

Budget expected

- \$7,2 mln. (\$5,7 mln. (EU) + \$1,5 mln. (Government)
