- **Development of waste management in Almaty region**, or selected priority project(s) within the region (FS prepared for entire region, includes construction/reconstruction of 16 landfills, supporting infrastructure and equipment; and closure of existing dumpsites)
- Feasibility study in Almaty city dumpsite operated by private holding company Tartip on landfill gas utilization for energy production (?)
- Maybe (?): waste management projects (potential investment projects in nearest future having FS), e.g. Aktobe, Atyrau, Kostanay, Pavlodar, Ust-Kamenogorsk, ...

- Assessment and development of action plan for restoration of riparian forests in Kyrgyzstan

Capacity development project

- Provide assistance to finalise national Environmental code and ensure its coherence with the EU Environmental policies, requirements, and practices

- Utilisation of used fluorescent lamps.
 - Technical assistance for feasibility study
 - Implementation of infrastructure project.



Potential for regional project

- Solid waste management development
 - Technical assistance to elaborate feasibility studies, EIA, project applications for priority investment projects defined in the Strategy,
 - Implementation of infrastructure projects.
- Technical assistance for institutional capacity building projects of public entities involved in project identification, planning and implementation.

- Investment projects in SHW and radioactive waste management systems.
