### 1 Waste management project in the city of Samarkand

#### DESCRIPTION DU FINANCEMENT

- ❖ **Amount of the financing: 31.5 m€**
  - An AFD loan of 23.5 m€
  - An IFCA grant of 8 m€
- ❖ **Signing date with the Republic of Uzbekistan:** December, 19<sup>th</sup> 2016
- ❖ **Project objective:** to implement an integrated waste management system in the city of Samarkand, in line with best international practices
- ❖ **Project components :** waste collection, waste transport, sorting facility, bioreactor landfill, landfill gas recovery, technical assistance

#### STATUS OF OPERATIONS

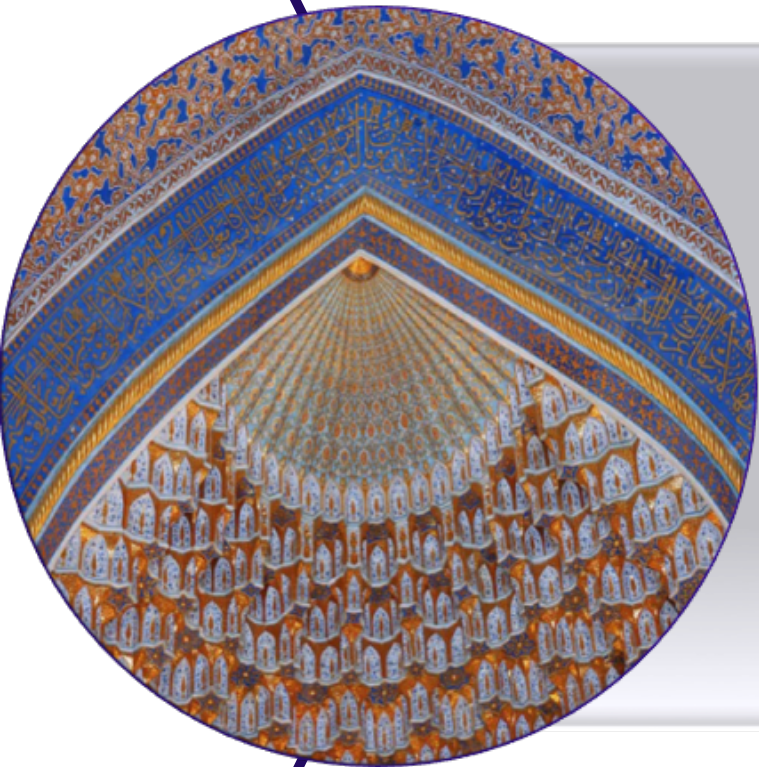
- ❖ **Feasibility studies completed**
- ❖ **Publication of the presidential decree** related to project implementation
- ❖ **Preparation phase of project launching under going :**
  - Project operational manual validated
  - Uzbek feasibility study approved
  - Recruitment of the PIU head (under going)

- ❖ Launching of the bid tender for TA & detailed design



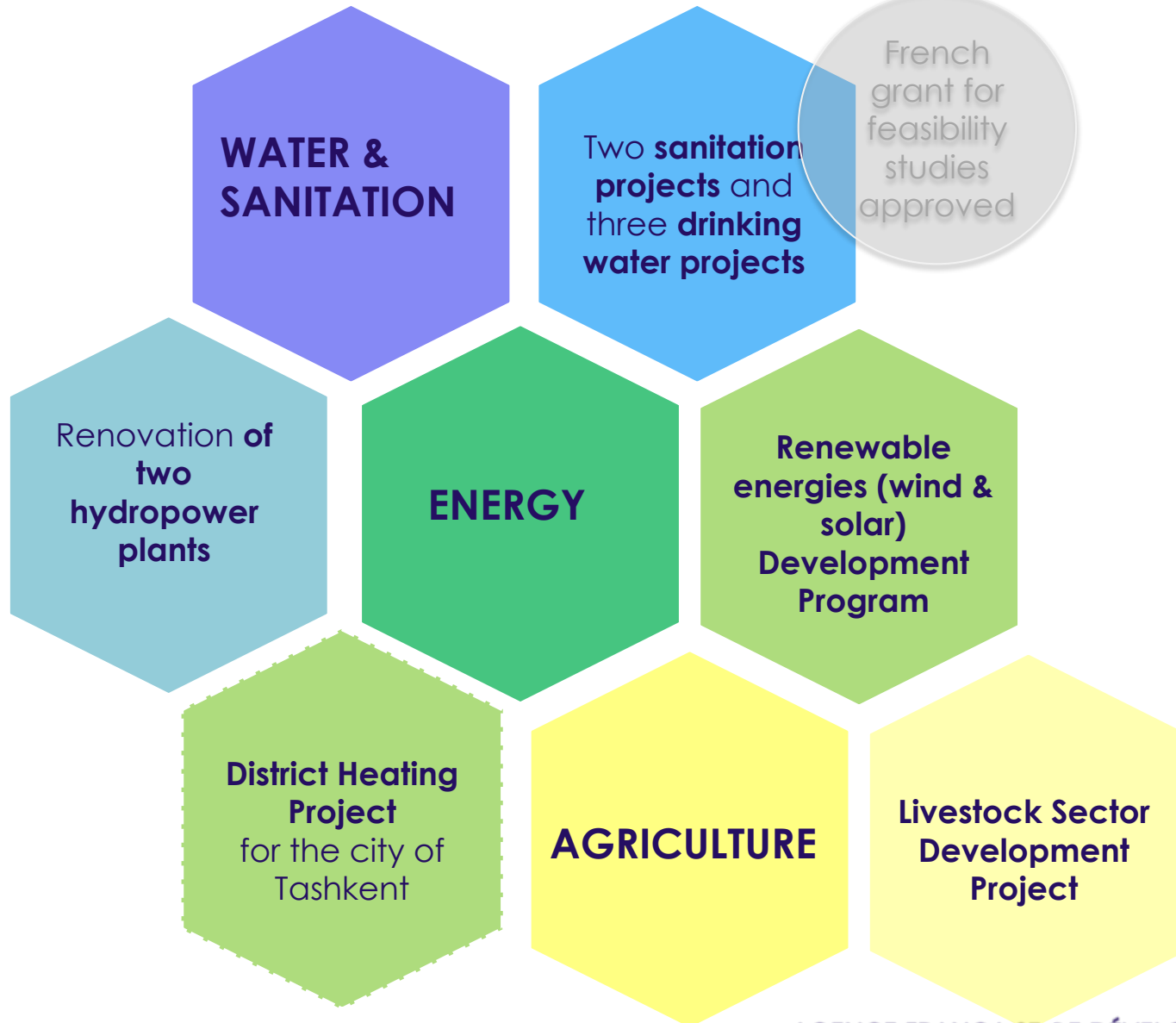
# 3 PROSPECTS IN UZBEKISTAN

Project name	Description	Complementary TA/IG
Livestock Sector Development Project	Provision of working capital and investment financing for livestock private stakeholders	Technical assistance and guarantee fund for farmers, private farms & enterprises engaged in livestock production and processing
Sanitation modernization Program in Kachkadarya and Navoi	Renovation and building of sanitation infrastructures	Technical Assistance, financial assistance to poor isolated households, valorization systems of sludge
Water Supply Modernisation Program	Reconstruction of water supply systems and construction of water pipelines	Technical Assistance and complementary investments such as the construction of new water networks in isolated village
Renewable energies Development Program	Building of a solar electricity generation plant and a wind electricity generation plant	Technical Assistance and complementary investments such as electricity distribution to nearby isolated rural communities

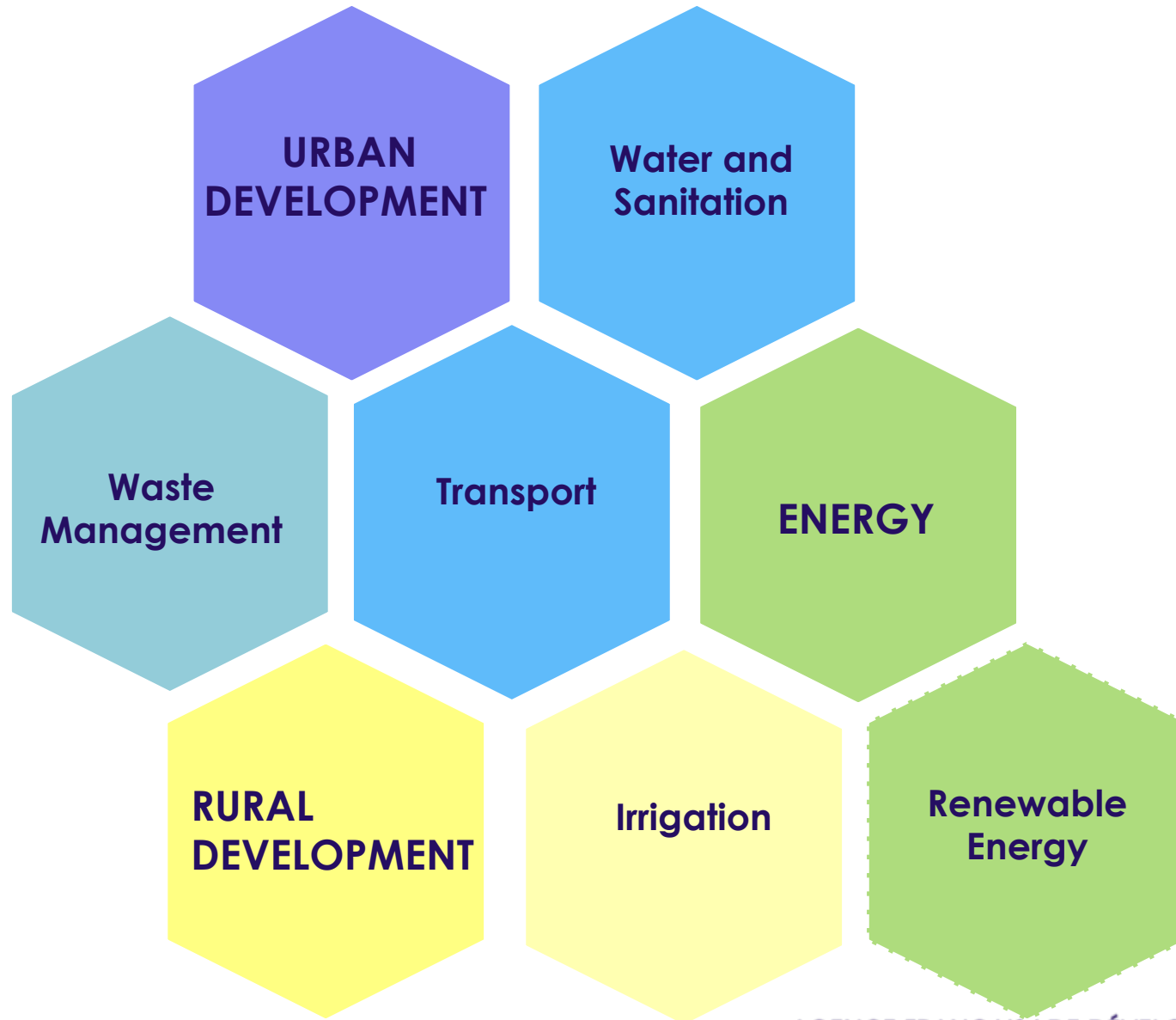
